

# MOBILE PHONES/SMART WATCHES - STUDENT USE

#### **PURPOSE**

To explain to our school community the Department's and Botanic Ridge Primary School's policy requirements and expectations relating to students using mobile phones and other personal mobile devices (smart watches) during school hours.

#### **SCOPE**

This policy applies to:

- 1. All students at Botanic Ridge Primary School and,
- 2. Students' personal mobile phones and other personal mobile devices (smart watches) brought onto school premises during school hours, including recess and lunchtime.

#### **DEFINITIONS**

A mobile phone is a telephone with access to a cellular (telecommunication) system, with or without a physical connection to a network. For the purpose of this policy, "mobile phone" refers to mobile phones and any device that may connect to or have a similar functionality to a mobile phone such as a Smart watch.

#### **POLICY**

Botanic Ridge Primary School understands that students may bring a personal mobile phone and other personal mobile devices (smart watch) to school, particularly if they are travelling independently to and from school.

At Botanic Ridge Primary School:

- Students who choose to bring mobile phones to school must have them switched off and securely stored during school hours
- Personal mobile devices / Smart Watches can be worn but must have the following functionality turned off during the school day; notifications, phone, camera and messaging services, browsing.
- Exceptions to this policy may be applied if certain conditions are met (see below for further information)
- When emergencies occur, parents or carers should reach their child by calling the school's office.

## Personal mobile phone use

In accordance with the Department's <u>Mobile Phones — Student Use Policy</u> issued by the Minister for Education, personal mobile phones must not be used at Botanic Ridge Primary School during school hours, including lunchtime and recess, unless an exception has been granted.

Where a student has been granted an exception, the student must use their mobile phone for the purpose for which the exception was granted, and in a safe, ethical and responsible manner.

## Secure storage

Mobile phones & smart watches owned by students at Botanic Ridge Primary School are considered valuable items and are brought to school at the owner's (student's or parent/carer's) risk. Students are encouraged not to bring a mobile phone / smart watch to school unless there is a compelling reason to do so. Please note that Botanic Ridge Primary School does not have accident insurance for accidental property damage or theft. Students and their parents/carers are encouraged to obtain appropriate insurance for valuable items. Refer to the Botanic Ridge Primary School's Personal Property Policy AND/OR the Department's Claims for Property Damage and Medical Expenses policy.

Where students bring a mobile phone to school, Botanic Ridge Primary School will provide secure storage. Secure storage is storage that cannot be readily accessed by those without permission to do so. At Botanic Ridge Primary School students are required to store their phones either at the office or locked in their classroom teachers locked filling cabinet/cupboard in the learning community. The same secure storage can be provided for smart watches, or they can be worn if the following functionality is turned off during the school day; notifications, phone, camera, messaging services and browsing.

#### **Enforcement**

Students who use their personal mobile phones and other personal mobile devices (smart watches) inappropriately at Botanic Ridge Primary School may be issued with consequences consistent with our school's existing student engagement and wellbeing policies.

The device will be removed from the child and a parent / carer will be contacted to collect it from the office if a breach of this policy occurs.

At Botanic Ridge Primary School inappropriate use of mobile phones is **any use during school hours**, unless an exception has been granted, and particularly the use of a mobile phone / smart watch:

- in any way that disrupts the learning of others
- to send inappropriate, harassing or threatening messages or phone calls
- to engage in inappropriate social media use including cyber bullying
- to capture video or images of people, including students, teachers and members of the school community without their permission
- to capture video or images in the playground, school toilets, changing rooms, swimming pools and gyms
- during exams and assessments

## **Exceptions**

Exceptions to the policy:

- may be applied during school hours if certain conditions are met, specifically,
  - o Health and wellbeing-related exceptions; and
  - o Exceptions related to managing risk when students are offsite.
- can be granted by the Principal, or by the teacher for that class, in accordance with the Department's Mobile Phones Student Use Policy.

The three categories of exceptions allowed under the Department's <u>Mobile Phones — Student Use</u> <u>Policy</u> are:

# 1. Learning-related exceptions

Specific exception	Documentation
For specific learning activities (class-based exception)	Unit of work, learning sequence
For students for whom a reasonable adjustment to a learning program is needed because of a disability or learning difficulty	Individual Education Plan

# 2. Health and wellbeing-related exceptions

Specific exception	Documentation
Students with a health condition	Student Health Support Plan
Students who are Young Carers	A localised student record

# 3. Exceptions related to managing risk when students are offsite

Specific exception	Documentation
Travelling to and from excursions	Reviewed through risk assessment planning documentation as to whether it is necessary
Students on excursions and camps	Reviewed through risk assessment planning documentation as to whether it is necessary

Where an exception is granted, the student can only use the mobile phone / smart watch for the purpose for which it was granted.

## Camps, excursions, and extracurricular activities

Botanic Ridge Primary School will provide students and their parents and carers with information about items that can or cannot be brought to camps, excursions, special activities and events, including personal mobile phones/ smart watches.

#### **Exclusions**

This policy does not apply to

- Out-of-School-Hours Care (OSHC)
- Out-of-school-hours events
- Travelling to and from school
